I will notify them of any medical needs and coordinate care in advance, unless it is an emergency, **LJ Acres Animal Life Center** will be notified as soon as possible of any medical emergencies that arise with the foster animal/s.

I also agree to hold **LJ Acres Animal Life Center** harmless for the cost of any medical treatment of my non-fostered animals or any persons in my household. **LJ Acres Animal Life Center** will provide all foster caregivers the food, equipment and supplies they need to care for their animal/s they are fostering.
